



1. EXECUTIVE SUMMARY

Exactly nine years ago in 2012, The National Gay and Lesbian Human Rights Commission Legal Aid Centre was founded with the main objective of seeking redress for LGBTQA + persons in Kenya who face human rights violations due to their real or perceived SOGIE-SC status. This was after a research on the lived realities and access to justice was conducted prior to the inception that highlighted the fact that there is a need for access to justice for LGBTQA+ persons in Kenya. Since then the Commission has been the go-to organization for the LGBTQA+ citizenry including asylum seekers who seek redress for violations fuelled by their SOGIE-SC status.

In the beginning, the organization had no physical space and client meetings with the lawyers were conducted in hotels, parks and other public spaces. In the subsequent years through fundraising the Commission was able to secure a space where clients could walk in to seek legal assistance, other than that the Commission acquired telephone numbers and email addresses that clients could call/email or text in the event that they were unable to come to the office or were out of Nairobi. The Commission has equally trained and certified paralegals countrywide who respond to cases first hand and refer the cases to the Commission in the event that there is a need for further intervention by the Commission.

We expanded our legal aid upon receipt of numerous cases from counties other than Nairobi. The caseload received from our partners and paralegals from out of Nairobi were increasing and it was a general consensus that it was necessary to have Mobile Legal Aid Outreaches in counties that had an increasing number of violations reported. In late 2016, we commenced the first Mobile Legal Aid Outreach which involves having lawyers from the organization setting up offices for two or three days in different counties in Kenya. Since then, NGLHRC has Memorandum of Understanding with various peri urban and rural LGBTQ+ organizations to conduct mobile legal aid clinics. We have had mobile legal aid clinics in Eldoret, Migori, Nakuru, Kisii, Kitui, Mombasa, Kilifi and Meru Counties. From these counties, the legal team has received myriad of cases ranging from disownment from families, disinheritance, divorce, sexual and physical assault, forced marriages, correctional rape, blackmail and extortion



among other cases.

Since July 2020 to June 2021 the Commission has received and handled 619 cases reported by LGBTIQ+ persons across the country. There has been significant increase in the number of cases, this could have been due to the ongoing pandemic. Covid-19 rendered quite a number of our constituents jobless and with no means of survival hence they had to go back home and were stuck with either abusive partners or abusive family members. This therefore resulted in cases of intimate partner violence, evictions, family rejections, economic indignity, discrimination and stigma among other cases discussed in detail herein.

In tandem with the spirit of constitutionalism¹NGLHRC has in the past year, resulted in Alternative Dispute Resolution (ADR) mechanisms such as mediation, arbitration and reconciliation. These services were provided for by experts in ADR and have been an effective, swift and cheaper method to settle disputes from the court and the media's glaring eye thus ensuring our clients have their rights to dignity and privacy upheld while settling the matters out of court. Since we launched this service, we have received a couple of requests for ADR by our clients. We hope that this would be an avenue that our constituents can consider as a mode of settlement in the future.

The Commission received cases from the following regions; Trans-Nzoia, Kisumu, Kwale, Kakamega, Lodwar, Kajiado, Uasin-Gishu, Kiambu, Machakos, Murang'a, Homabay, Chuka, Meru, Eldoret, Mandera, Kilifi, Kakuma, Siaya, Nairobi, Embu, Miritini, Kilifi, Kwale, Mombasa, Nairobi, Nakuru among other counties. Additionally we served clients from Ethiopia and Tanzania who sought the Commission's help to intervene in instances of human rights violations.

2. LEGAL AID SUMMARY

The present legal aid report has been prepared pursuant to the mandate of the Commission on provision of legal protection for LGBTIQ+ population as well as the cases reported at the Legal Aid Center. The report summarizes the trends, nature and number of human rights violation cases reported at the Legal Aid Center. The cases herein are human rights violations occasioned on LGBTIQ+ populace based on their perceived Sexual Orientation, Gender Identity and/or Expression and Sex Characteristics.

Although the State is legally designated as the key duty bearer to respect, protect, promote and fulfil basic rights including the provision of legal assistance to every citizen within the Republic of Kenya, this has not been forthcoming, especially for the LGBTIQ+ populations. During this period, there was a jump in cases of human rights violation based on SOGIE-SC that were reported at the Legal Aid center, notably during As the pandemic escalated, we adopted safety measures to ensure safety for both our constituencies and staff. Within a month, most of our services were being delivered remotely and in-person services were restricted to exceptional circumstances. Usually averaging 500+ calls each year, our Legal received over 400+ calls in the first few months of the pandemic. To manage this significant shift, we coordinated staffing and support to respond to the rising need for legal aid services, rapid response, crisis response therapy and security response. Although in-person contact was restricted this year, we continued to deliver community legal education to our constituencies online. We also launched the soft IEC materials aimed at educating our diverse communities and stamping out human rights violations i.e conversion therapy that was on the rise following stay-at-home government directives.

Throughout the pandemic year, the Legal Aid Centre provided a wide range of legal services in the areas of Civil including forced evictions, discrimination, stigma etc, Criminal, Employment, Family and our specialist legal service to the LGBTQ+ communities. This year was marked by a 50% increase in the number of SOGIE-SC human rights violations as compared to the previous years that recorded margins of increase at 20%. The COVID-19 pandemic played a major role in exacerbating inequalities prevalent and the increase in number of cases reported at the Legal Aid center. Further, the Stay-at-home directives, isolation, increased stress and exposure to disrespectful family members exacerbated the risk of violence, with particular impact on LGBTIQ+ youth. Restrictions of movement created exacerbated risk of abuse during street controls, with reports of selective arrests; hate crimes such as harmful exposure on social media; arbitrary detentions and a general increase in mistreatment in the public sphere.

TRENDS IN 2020/2021

- The ongoing pandemic rendered quite a number of our constituents jobless since quite a number depend on odd jobs for survival. This then resulted in loss of livelihood hence they could not sustain themselves resulting in evictions and homelessness.
- Loss of livelihood and closure of institutions of learning resulted in our citizenry resorting to going back to either homophobic/transphobic partners and parents or abusive partners resulting in a lot of physical and verbal violence.
- There have been cases of blackmail and extortion among GSM community where some GSM collude with the police to extort other queer persons
- There has been an increase in the number of clients seeking therapy and psychosocial support this is a result of the effects of the pandemic that resulted in working from home, loss of livelihood and lack of social gatherings
- Requests for renewal of valid documentation by the queer refugee citizenry has significantly risen since RAS office was closed due to the pandemic and government guidelines on not issuing identification documents to asylum seekers.
- The pandemic has resulted in a downturn in funding hence quite a number of LGBTIQ+ organizations have been able to institutionally run their operations and activities and are at the verge of shutting down after the lapse of their previous funding.
- Cases of Intimate Partner Violence have steadily risen over the past year within our citizenry.
- There has been an increase in inquiries and requests generally varying from requests for legal assistance, requests for basic amenities, requests for food, financial and medical assistance e.t.c
- There has been an increase in requests for food baskets and food vouchers as a result of loss of source of livelihood by a number of our constituents.
- Homophobic, transphobic and biphobic attacks against LGBTIQ+ persons in Kakuma Camp has steadily risen.
- There has been an increase in requests for financial assistance by partner organizations to carry out activities within their environs.
- There has been an increased number of cases in homophobic attacks against queer Human Rights Defenders (HRDs) some unfortunately resulting in murder.

- There has been an increase of cases involving minors (Below the age of 18) that falls beyond the scope of the Commission's mandate.
- There have been quite a number of cases of police raids and arbitrary arrests in a number of refugee safehouses.
- Incidents of threats to life/physical assault and verbal assault have been rampant from perpetrators well known and unknown to the clients.
- State officers have continuously acted ultra vires by arbitrarily arresting LGBTQ+ persons without charging and arranging them in court and threatening them with section 162 of The Penal Code.
- State officers have continuously harassed, blackmailed and extorted queer persons while threatening to charge them with the provisions of section 162 and 165 of the Penal Code.
- Lack of valid documentation for queer asylum seekers has resulted in limiting movements due to fear of being arrested, and extorted by state officers who often ask for bribe to arrest those without updated documents.

IDENTIFYING NEEDS

- There is a need for economic empowerment on income generating activities to ensure our clients have economic dignity and lead more stable lives after relocation.
- There is a need for dialogues between local authorities in areas where safehouses are located to avoid police raids and harassment.
- There is a need for sensitization on age and consent so as to avoid cases of defilement/involving minors amongst our citizenry.
- There is a need for training on funding and funding opportunities for LGBTIQ+ startup organizations.
- There is a need to continuously carry out sensitization and advocacy training on various stakeholders such as the police, judiciary, health workers as well as parents on the need to protect and uphold the rights of LGBTQ+ persons.

- There is a need to expand the relocation funding as there are a number of requests for relocations especially with the ongoing pandemic that has resulted in loss of livelihood for a number of our citizenry.
- There is a need for security reinforcement in Kakuma Camp or /dialogues between the other communities and queer community in Kakuma.
- There is a need to petition the government to resume registration and refugee status determination for LGBTQIA+ asylum seekers and others in Kenya.
- Paralegals who continuously refer us to cases from different counties require stipends to do the work, or for purposes of their general protection and appreciation
- There is a need for more funding to carry out our legal aid clinic diligently as well as to meet our client requests.
- There is a need for sensitization on the rule of law and the applicability of laws of Kenya to everyone who contravenes them and the repercussions thereof.
